Monmouth County High Schools Unite for the Environment

On March 26, student representatives from six Monmouth County high schools announced events at their schools to promote ocean advocacy and inspire others to make a difference in the environment. The students represent "Student Ocean Advocates" (SOA), a new program of Clean Ocean Action (COA). The students from the schools collectively decided to address the issue, "Ocean pollution caused by apathy impacts the quality of life," by hosting environmental awareness days at their respective schools.

"Our belief is that there is nothing more detrimental to our environment then a lack of enthusiasm," said **Cristina Meinz** of Fair Haven. Cristina is a COA intern for her Rumson-Fair Haven Regional High School (RFH) senior project and coordinator of the inaugural program of SOA.

SOA was created as an outlet for activism on issues related to the health of the ocean. Students meet twice monthly in the evening to discuss issues and actions to stop ocean pollution among their peers, and report to their fellow students in their respective schools. The group first met in December 2006. The participating SOA schools are: Academy of Allied Health and Science (AAHS), Henry Hudson High School (HHHS), Long Branch High School (LBHS), Marine Academy of Science and Technology (MAST), Rumson Fair Haven Regional High School (RFH), and Wall High School.

Students reached-out to local organizations for ideas, donations, and participation in their events. The Eatontown Environmental Commission, represented by Ed Dlugosz, provides space in the Eatontown Community Center for SOA meetings, and arranged with the Monmouth County Friends of Clearwater, for which he is President, to donate copies of *An Inconvenient Truth*. Many schools will also showcase local environmental organizations who will provide activities, volunteer opportunities, and display tables.

The environmental days will be held in late March and throughout April. Students arranged activities, such as student pledges to for the environment, sales of T-shirts and biodegradable ornaments, a poster contest, and planting session in a town's community garden. Some students will dye their hair blue in support of a clean ocean! Other activities include a plastic bottle "Recycling War" during lunch periods, donation drive for used sneakers to be recycled into sports courts, and distribution of energy-efficient compact fluorescent bulbs.

COASTAL WATER QUALITY

Oyster Creek Does Not Conform to NJ's Environmental Laws

COA and the American Littoral Society submitted extensive scientific, legal, and policy-based comments to the New Jersey Department of Environmental Protection (NJDEP) challenging the claim by AmerGen -- owners of the Oyster Creek Nuclear Generating Station (OCNGS) -- that operations at the plant are in keeping with NJ's environmental laws. The destructive cooling water intake system causes severe adverse effects on the Barnegat Bay marine environment due to impingement, entrainment, thermal discharge, and chlorination.

COA and ALS thank the groups who signed onto our comments: Save Barnegat Bay, NY/NJ Baykeeper, Raritan Riverkeeper, Fisherman's Dock Co-op, Inc., Asbury Park Fishing Club, Surfrider Foundation, Natural Resources Protective Association, and WATERSPIRIT. Monmouth Park Racetrack Takes Some Steps To Clean Up Its Act

The Monmouth Beach Environmental Commission invited COA, NJDEP, and Monmouth County Health Department to participate in a meeting to discuss water quality issues with nearby Monmouth Park Racetrack (MPRT). During last summer, bacteria levels were consistently high in Branchport Creek (*picture right*). The cause was a broken valve that allowed wastewater from the horse paddock area to spill into the creek. The MPRT is required to send the waste to the local treatment plant, but failure to inspect and maintain the wastewater system led to the illegal discharge.



MPRT agreed to immediately implement a list of improvements recommended by NJDEP. COA will submit a list of recommendations to NJDEP, including the installation of a flow meter at the outfall pipe to record any discharges.

Group to Tackle Nitrogen Problem in Barnegat Bay

Clean Ocean Action participated in a roundtable discussion on the impacts of excess nitrogen entering Barnegat Bay. The meeting was organized by **Save Barnegat Bay**, a member of our coalition that works to conserve undeveloped natural land and clean water throughout the Barnegat Bay watershed.

The meeting began with a description of the problem by Dr. Michael Kennish from Rutgers University. Dr. Kennish's ecological studies in the Bay over the past 30 years have given him first-hand knowledge of the impacts of excess nutrient enrichment or "eutrophication," including massive brown tide algal blooms, excess growth of sea lettuce, the crash of the hard clam fishery, and the invasion of stinging sea nettles.

The group devised a three-pronged strategy to combat excess nitrogen, which will include science, policy, and legal tools. The group plans to meet again to further define our goals and to develop and implement the necessary actions to achieve them. If you are interested in participating, please contact Jenni at COA.

COA Goes to DC for Clean Water



In February, Kari Martin, COA's Policy Communications Director, participated in The Clean Water Network's biennial conference, "Clean Water Week," in Washington, DC. More than 100 participants attended from across the country to discuss clean water issues, problems, and solutions. On the final day of the conference, attendees

visited US Senators and Representatives from their states to discuss legislative actions to address water pollution issues, such as the Clean Water Authority Restoration Act and the State Revolving Fund (HR 720). During the visit, Kari met and spoke with staff members for both US Senators from New Jersey and several US Representatives. 

Common Sand Dollar Echinarachnius parma

February's Creature Feature was the **common sand dollar**. Common from New Jersey northward along the New England coast, this relative of the sea star lives in the intertidal zone, where they often bury themselves for protection and feeding. Using only its tiny spines and tube feet, the sand dollar takes about 10 minutes to become completely buried. Luckily, not many creatures bother trying to eat this small, hard animal. Sand dollar eggs are an important tool in cancer research and other molecular studies on cells. Congratulations to **Jan Heller** for being chosen among the several correct entries.

April Creature: Don't be fooled by this benthic creature, because it isn't what it appears to be from its common name. By day, they hole-up in sand or mud burrows, but at night, this aggressive predator hunts live prey with its spearing claws. They are thought to have the fastest strike in the Animal Kingdom. In fact, the swift, "snapping" action of their jackknife-like claws
