Stormwater Permits Show Progress, Improvements Still Needed

The NJ Department of Environmental Protection (NJDEP) recently issued a Draft Renewal Municipal Stormwater General Permit. The permit is required to allow stormwater discharge through the storm drainage systems of municipalities (Tiers A and B), and highway agency and public complexes.



The draft permit proposed to eliminate a 7-day yard waste timeframe


between street placement and pickup, which would allow waste to sit indefinitely. Prolonged leaf litter on streets increases likelihood of clogged storm drains and nutrient pollution to our waterways. COA urged that this time limit not be eliminated, but extended to 14-days to accommodate the needs of citizens and municipalities to gather and collect waste in a reasonable time frame.

Leaking refuse and waste containers were also identified as pollution sources. A new Refuse Container Ordinance in the permit will require inspection and compliance to prevent pollution. In addition, COA recommended that a statewide fertilizer management ordinance be implemented to reduce nitrogen pollution to coastal waters, and insisted that the permits be modified for consistency with federal laws and requirements, such as the Endangered Species Act.

Coalition, Citizens, and Officials Against Offshore Drilling

COA submitted comments on behalf of 21 organizations and 16 concerned citizens to the U.S. Department of Interior's Minerals Management Service (MMS) to stop the proposed sale of a lease area off nearby Virginia's coast for oil and gas drilling. Leasing this site for exploration and drilling flies in the face of 25 years of good governance policies to protect environmentally sensitive areas, counters efforts to reduce climate-changing greenhouse gas emissions, and puts the regional economic and environmental productivity and potential at risk for a small amount of oil and gas. Using 2030 national consumption rates, MMS estimates that the area off Virginia contains only enough recoverable oil for 1.8 to 2.9 days, and for 3.4 to 6.8 days for natural gas.

Congressional leaders -- including US Senators Menendez and Lautenberg (both D-NJ), US Representatives Pallone (D-6), Holt (D-12), Sires (D-13), Payne (D-10), and Pascrell (D-8) from NJ, and Rep. Hinchey (NY-D-22), Moran (VA-D-8), and Markey (MA-D-7) sent a

joint letter to MMS, expressing concern for the "fragile coastal ecosystems and economies of coastal states" and argued. "to put our beaches, fishing, and tourism economy at risk for such minimal resources is short-sighted."

Also, US Senator Menendez (D-NJ) secured a commitment to give coastal states a seat at the table as plans for potential drilling along the coasts is considered.

Rising Waters & Pollution

Recently, the Jacques Cousteau National Estuary Research Reserve Program held a planning workshop on sea level rise for the mid-Atlantic coast. The heavily populated and developed coastline of New Jersey is vulnerable to sea level rise and presents many challenges for communities. Climatic changes have been also predicted to increase the intensity of rain events in New Jersey, thereby also increasing the risks of flooding and storm-related pollution. New Jersey has lost coastal wetlands over the last century. Reductions in natural coastal buffers, such as wetlands, expose land areas and also decrease the buffer's capability to entrap sediments and contaminants, resulting in greater sediment loadings and pollution to coastal waters.

COASTAL CREATURE FEATURE




Amethyst Gem Clam Gemma gemma

The December creature feature was the amethyst **gem clam**. This tiny bivalve is found in sediments from intertidal waters to depths of 6 meters (or about 20 feet). They live up to three years and may reproduce in the spring and fall. Water fowl, snails, crustaceans (i.e., amphipods, crabs, shrimp), and some cnidarians (i.e., sea anemones, hydrozoa) all feed on the gem clam. Judge Jewel B. Valve congratulates the contest winner, Douglas Lopez of Keyport, NJ, for his correct guess!

February's creature feature is a popular panfish that is commonly found from Cape Hatteras to Cape Cod. The fish can weigh as much as 3.3 pounds and has an average lifespan of 15 years. The fish is a bottom feeder

that eats small crustaceans, worms, and molluscs.
