Featuring... Asbury Park Fishing Club

What is the oldest saltwater fishing club in the United States? The Asbury Park Fishing Club, of course. In 1888. James A. Bradley, founder of the City of Asbury Park, and nine of his friends formed an informal surf fishing club. By 1890, it took the official name of "Monmouth County Protective Association." The name was changed to the Asbury Park Fishing Club in 1902 and a new constitution and purpose. "To protect saltwater game fish, to create good fellowship, and to promote the interest of anglers," were adopted. Today, the Club's 200 members all have a love of the sea and saltwater angling.

To help fulfill its purpose, the Club joined forces with other organizations, including Clean Ocean Action, to tackle many issues, such as pollution. The Club and its members, including COA Board of Trustees Member Bill Feinberg, took action against ocean dumping over the years, but are now working to stop other sources of pollution to our waterways and the ocean.

"The amount of pollution from our communities entering our waterways. and ultimately the ocean, is unbelievable and needs to be stopped," said Joe Pollatta, President of the Club.

Recently, the Club took action to stem litter problems at the Deal Lake flume. The spacing in the flume grate was too large, thereby allowing large amounts of litter to flow into the ocean. The Club successfully pressured NJDEP to reduce the size of the spacing.

In addition to working on issues. proceeds from the Club's Annual Fishing Flea Market, held in Convention Hall, are donated to fishery conservation and to the City of Asbury Park to help promote its rebirth. Also, the Club hosts two barbecues a year, an annual cleanup of Deal Lake and neighboring beaches, annual awards dinner, and Spring and Fall fishing tournaments. Brown Funk Unwelcome Start to Summer Season

Though the weather was beautiful, from Raritan Bay to Avon-by-the-Sea, one of the largest brown algae blooms in recent memories stained the near shore waters and disgusted beach-goers on Memorial Day weekend. COA received many calls from citizens reporting the brown funk in the water as northeast winds kept the algae near shore. A west wind on Monday blew the mass offshore. The algae bloom is not harmful to humans, but can be harmful to marine life. Blooms are not unusual, especially in the spring and late summer, but this bloom was unnatural in size and scope.

EPA Pulls Plug on Monitoring the Ocean

As citizens raise serious concerns about a massive algae bloom (see above), EPA pulls the plug on important water quality monitoring: dissolved oxygen and bacteria. COA and Rep. Pallone (NJ-D-6) are both investigating.

Are You Swimming in a Sewer?

At a May 25th press conference in Avon-by-the-Sea, NJ, US Senator Frank Lautenberg (D-NJ) and US Representative Frank Pallone, Jr. (NJ-D-6) (pictured right), announced the introduction of the Beach Protection Act of 2007. The bill ensures reauthorization of the BEACH bill, which requires national monitoring of swimming beaches and key enhancements to the current law. These include more money, track down of sources of pollution, accountability, and requirements for a rapid water testing method (see related article).

Rapid Testing for Bacteria at Beaches Coming to NJ

After years of urging by Clean Ocean Action (COA), the NJ Department of Environmental Protection (NJDEP) is teaming-up with the US Environmental Protection Agency (EPA) to investigate a new rapid method for detecting bacteria in marine waters. The current method for weekly beach and bay water monitoring takes 24 hours to get results, while the rapid test can take as little as three. With the 24-hour method, it can take up to three days to close beaches that is polluted with bacteria, making shore activities such as swimming and surfing risky and unhealthy. If shown to be reliable, the new. rapid method would be much more protective of public health by allowing beaches to be closed and reopened more quickly. Finding Solutions To Pollution In and Around Wreck Pond

US Representative Chris Smith (NJ-R-4) organized a meeting in Spring Lake, N.J. with US Representative James Oberstar (MN-D-8). Chair of the US House Transportation & Infrastructure Committee, to discuss coastal water conditions in and around Wreck Pond. The meeting, which COA attended, was part of an ongoing effort by Rep. Smith to secure federal funding for dredging Wreck Pond to improve water flow and habitat, and to prevent bacterial contamination of the surrounding ocean waters. So far, NJ has payed the bill for dredging sand that accumulated on the oceanside of the pond, and extending the ocean outfall pipe an additional 300 feet offshore. These two measures have met with limited success, as the ocean beaches surrounding the outfall pipe from Wreck Pond remain on mandatory closure after 1/4" of rainfall. This summer, the Beacon Blvd, Beach in Spring Lake will be added to that precautionary closure list after monitoring results in 2006 indicated the extension of the pipe may have pushed the plume from the outfall farther south.

Actions Against Offshore Drilling At a May 4th press conference in Bradley

Beach, US Representative Frank Pallone, Jr. (D-6) was joined by Mayor Stephen Schueler, NJDEP Deputy Commissioner Jay Watson, and representatives of the Surfrider Foundation, New Jersey Environmental Federation, Jersey Coast Anglers Association, American Littoral Society. Sierra Club - NJ Chapter, and Surfers' Environmental Alliance to object to offshore oil and gas drilling in the Mid-Atlantic, specifically

In February, Rep. Pallone introduced the COAST Anti-Drilling Bill (H.R. 777), which would permanently ban offshore oil and gas drilling from Virginia to Maine. US Senators Robert Menendez (D-NJ) and Frank Lautenberg (D-NJ) introduced a bill by the same name in the US Senate earlier this year as well.

Draft Released on Environmental Impacts of New Energy

COA reviewed the draft Programmatic Environmental Impact Statement (PEIS) released by the Minerals Management Service (MMS), a federal agency, and found the draft flawed, incomplete, and lacking scientific justification for ecological impacts, assessments, and conclusions. The PEIS makes assumptions and conclusions about the impacts of offshore alternative energy facilities, while acknowledging a lack of scientific information or data. Several potential impacts were identified, including the noise during pile driving, collisions between construction and maintenance vessels and marine mammals and sea turtles, and the disruptive electromagnetic field generated from the transmission cable that runs from facilities to the shores. However, the PEIS assumed the impacts from these and other activities would be negligible to minor, without providing any scientific support. The most glaring omission was the failure of MMS to consider the cumulative impacts of multiple facilities along the entire coastline, citing a lack of information on where the facilities would be located. The main responsibility of the PEIS should be to look at the "big picture" and assess the cumulative impacts of the entire offshore alternative energy program.

COA urged MMS to substantially improve the Draft PEIS by conducting a thorough scientific review of the potential impacts of alternative energy production facilities on aquatic resources, including the cumulative impacts of multiple facilities, which may have far-reaching effects on migrating marine birds, mammals, and sea turtles. Draft Pollution Permit for Monmouth County Bayshore Facility

The Monmouth County Bayshore Outfall Authority (MCBOA) combines the treated wastewater or "effluent" from the Union Beach and Middletown Sewage Authorities before discharging it into the Atlantic Ocean near Sandy Hook. The Outfall Authority operates under an ocean discharge permit, which is set to expire. Reviewing the draft permit, COA found that although improvements have been made, there are still substantial issues that must be addressed: capacity and proposed removal of groundwater monitoring requirements, which is of great concern because MCBOA violated pollution limits in its current permit.



Although it is neither a shrimp nor a praying mantis, the Mantis Shrimp has taken the best features of both of these creatures to create one "super-predator" that can swim quickly through the water with its shrimp-like segmented body and paddle-shaped legs, while it Mantis Shrimp, Squilla empusa efficiently slashes at prey using its praying mantis-like

folding front legs. Fishermen call them "shrimp snappers" because their strong jack-knife claws can cut right through your hand with one quick slash. Found everywhere from the shallow bay to the deep ocean, these stomatopods hunt for crab, fish, shrimp and even each other!
