

#### **Christie Opposes LNG Import Terminals**

On October 6, Chris Christie, Republican candidate for NJ governor, announced his opposition to the three proposed liquefied natural gas (LNG) proposals off NJ. The industrial complexes are proposed to import foreign natural gas in a highly polluting method with great impacts to the ocean. Christie again emphasized this and other positions in a letter to COA on October 21 stating, "I would assure you that I do not support the introduction of LNG facilities into the New Jersey waters or the development of offshore drilling....On the other hand, I have enthusiastically supported the development of renewable energy to be one of our highest priorities, and I have been very clear about my commitment to green energies." Christie wrote that "preserving and protecting our coastline, as well as punishing corporate polluters who fouled our environment...will serve as a cornerstone of my Administration." Christie also called "for the adoption of greater protections from the nitrogen and phosphorous poisoning now occurring in Barnegat Bay." COA welcomes and applauds Christie's leadership on these issues, including LNG. Independent candidate Chris Daggett previously stated his opposition to LNG import terminals and Governor Jon Corzine supports the concept of LNG import terminals. Both Daggett and Christie also oppose an experimental proposal to build a coal burning fertilizer and energy plant in Linden. NJ, that includes a 100 mile pipeline to inject liquefied carbon emissions into the seafloor off the Jersey coast.

#### Monmouth County Freeholders Vote UNANIMOUSLY Against LNG

On October 22, the Monmouth County Freeholders voted unanimously in favor of a resolution opposing the construction of liquefied natural gas (LNG) import terminals in the region. The resolution noted the increased pollution that foreign LNG results in rather than domestic natural gas, which is in abundance. The Freeholders vote followed a recommendation against LNG terminals by the Monmouth County Environmental Council. The resolution was introduced by Freeholder John D'Amico, who emphasized the ecological importance of the marine waters. Freeholder Rob Clifton was "very happy" to vote on what he saw as a "Slam Dunk" issue - opposing imports of foreign LNG. Freeholder Lillian Burry also expressed her support but questioned why Governor Corzine could support LNG. Freeholders Barbara McMorrow and Amy Mallet added their strong support in passing the resolution. COA applauds the leadership of the Freeholders who worked in a strong non-partisan effort to protect the public interest as well as the coastal environment and economy of Monmouth County.

#### Obama Nominates "Insanity Island" Staffer to "Key Administration Post"

On October 14, President Barack Obama announced his intent to nominate Atlantic Sea Island Group employee Jessie Roberson as a member of the Defense Nuclear Facilities Safety Board, a "key administration post." The Board is an independent federal agency that oversees the Department of Energy's (DOE) nuclear weapons complex. Roberson worked for President George W. Bush from 2000-2004. In 2009 she joined the Atlantic Sea Island Group, who proposes a man-made island off NY and NJ designed to import foreign liquefied natural gas (LNG). COA is troubled that President Obama would nominate a person who supports such an ill-conceived, environmentally and technologically fatally flawed project to such an important position.

#### **President Obama Establishes Ocean Policy Task Force**

To develop recommendations for a national ocean policy. President Obama has established an Ocean Policy Task Force that has held six national public hearings. Cindy Zipf representing Clean Ocean Action spoke out in support of protecting a healthy ocean at the crowded East Coast meeting held in Providence, RI that more than 250 people attended. Several other NJ/NY region folks testified including Tim Dillingham from the American Littoral Society. Most compelling was 9 year old Billy Pellegrino (yes, son of famed coastal paddler Margo, who also testified). Billy politely yet emphatically called on the Task Force to make the ocean healthy for his future.

The oceans and coasts are under stress from multiple sources of pollution. climate change, and competing uses. "The Task Force has a wealth of opportunity to make our oceans, coasts and Great Lakes healthier - both environmentally and economically," stated Nancy Sutley, Chair of the White House Council on Environmental Quality and chairwoman of the task force. Sutley and Dr. Jane Lubchenco, head of the National Oceanic and Atmospheric From Left:

Administration, lead the meeting. More than 140 laws and 20 agencies govern ocean and coastal waters and resources, which now result in conflicts, confusion, and inaction. A unifying national policy based on sound science and stewardship is needed. Clean Ocean Action has submitted comments on the national ocean policy, marine spatial planning, and the Task Force's interim report, which are online. COA supports Obama's directive for a policy "to ensure the protection. maintenance, and restoration of our oceans and coasts.

#### Nassau County Legislator's Anti-LNG Taskforce



The Denenberg Taskforce Against the LNG Island was initiated by Nassau County Legislator Dave Denenberg, Chairman of the Planning, Development and Environment Committee. When Legislator Denenberg first learned of Atlantic Island Sea Group's Safe Harbor Energy proposal to build an LNG island off the shores of Long Island, he reached out to COA and became the first and only elected official in NY at the time to actively oppose this project and has been working closely with COA ever since. The Broadwater Project, an LNG platform that was proposed to be situated in Long Island Sound, had just been rejected by Governor Paterson. "If it's no good for the Sound, then it's no good for our ocean!" Leg. Denenberg exclaimed.

Denenberg held a press conference on the eve of the Long Beach hearing in January of 2009, which resulted in bringing 250 people to a meeting and media coverage of the hearing. He recruited Claudia Borecky and Beverly Visconti as co-chairs of the Denenberg Taskforce. The North Merrick Civic Association, Lido Beach Civic, the Freeport Tuna Club, the Long Beach City Council, the Sierra Club Long Island Group, LI Green, and several members of SPLASH soon joined in their campaign. Ms. Borecky and Ms. Visconti also chair Yes We Can LI's LNG Island Committee, which was instrumental in steering people to submit comments on NY's Draft Energy Plan. Legislator Denenberg's Taskforce also held a rally at a Farmingdale NY Energy Plan hearing, leading the opposition with a significant portion of the audience speaking out against LNG and coverage in Newsday and local papers.

"The oceans are the last of our open spaces," states Denenberg, who wrote Nassau County's Environmental Bond Act, which allows for the purchase and/or protection of open spaces. "The view from our beaches is the same view that has been seen by millions of people for thousands of years." adds Ms. Borecky. "It is our duty to protect and preserve our oceans for generations to come."
